## 1. General Event Information:

## 2. Payment:

- B. Sponsor agrees participation will not be permitted without full payment and compliance with the terms of this Agreement.

#### 3. Sponsorship Benefits:

The Sponsor fee includes sponsorship benefits as outlined on the SITE Mountain West event webpages.

## 4. Limited License:

Sponsor grants SITE Mountain West the right to use and reproduce Sponsor's name, trademark, personal image, and logo in connection with the promotion and production of the SITE Mountain West Summit: Discover Scottsdale and for the purposes of this Agreement.

# 5. General Terms:

Sponsor shall abide by and observe any laws, rules, regulations, and ordinances of the U.S., and all rules and regulations of SITE Mountain West and destination hosts in connection with its participation in the SITE Mountain West Summit: Discover Scottsdale as may be set from time to time.



Out of respect for our hosts and underwriters, all sponsors are required to limit entertaining clients only at designated Summit program events. Pre-organized private social functions outside the designated program are not permitted during the program dates of Sunday, August 16 through Monday, August 17, 2026 (including private dinners, hospitality suites, separate activities not included in the scheduled program). Organizing any external event that removes clients from any part of the designated program may result in (a) removal of sponsor's logo from all remaining communications and all current and future digital and printed assets (b) barring from participation in future SITE Mountain West Summit and other chapter events.

## 6. No Cancellation After Acceptance:

The Sponsor may not cancel sponsorship after acceptance of the Agreement for sponsorship of the SITE Mountain West Summit: Discover Scottsdale. No exceptions will be made to this policy. By accepting this Agreement, the Sponsor Company is required to make full payment by check or ACH to SITE Mountain West by the deadline established in the confirmation email. Name changes of the sponsor representative will be accepted up to thirty (30) days prior to the event. SITE Mountain West shall not be subject to any liability for any failure to hold the event because of an act of God or other event that is beyond their reasonable control, including, but not limited to, outbreak of hostilities, insurrections, riot, civil disturbance, terrorism, government act or regulations, fire, flood, or explosion. Inadvertent failures of either party to print, publish, or circulate the other party's name and/or materials shall not be considered a breach of the Agreement. Sponsors who fail to provide full payment for a sponsorship will be prohibited from registering or sponsoring at any future SITE Mountain West event.
